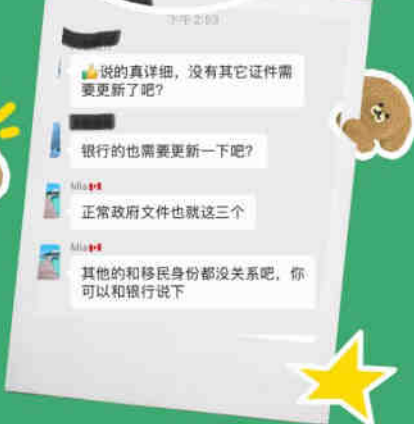

Your fingerprints may also be shared with law enforcement agencies in Canada and may be used for the enforcement of any Canadian or provincial law.
